

#### STYLE SHEET

This CBTS Style Sheet serves as a summary how papers and projects should be formatted for all CBTS assignments. The aim of this style sheet is to provide an accessible reference document so that Faculty and Students may quickly find clarity about stylistic/citation expectations.

#### A few general notes:

- All papers must be done in MS Word format and should be saved as a .doc or .docx with the following information in order:
- [Class code][space][student last name][space][a short assignment description].docx<sup>1</sup>
- Generally, CBTS style guidelines conform to Turabian's most recent edition of style; however, should the two conflict, CBTS style guidelines are to be used.
- If the CBTS Style Sheet does not address an element of style or citation, then Turabian's style will be expected.

## I. Page setup

- A. Top margin: 1"
- B. Bottom margin: 1"
- C. Side margins: 1"
- D. Page numbers: centered at bottom of page, no page number on the 1<sup>st</sup> page (i.e., Title Page).

#### II. Main text

- A. Font: Times New Roman, 12-point.
- B. Spacing: double.
- C. Left justify margins
- D. Indent for first line of each paragraph: 0.5"
- E. Note: for all number ranges (e.g., 1997–2003), use an en dash, not a hyphen.

#### III. Title page

- A. Book reviews over six pages in length and all term papers require a title page
- B. See example at the end of this document
- C. Title page and bibliography are not included in page count

## IV. Block Quote

- A. A block quotation is a quote over four lines
- B. Font: Times New Roman, 11-point
- C. Spacing: single

- D. Left justify margins, and do not use quotation marks ("") around the quote
- E. Indent whole paragraph: 0.5"
- F. Double space before and after the quotation (one line of space before and after).

Here is a sample block quote, given within the text of a paper:

Here would be the block quote text. Notice the absence of quotations marks surrounding the quote, and also notice that the first word is capitalized, even though the quote is found WITHIN the preceding sentence... Block quotes should be Times New Roman font, just like the preceding and succeeding sections, although the block quote will be 11-point font, rather than the standard12-point font. The block quote should be at least three full lines of text, should be single spaced, and should be justified to the left margin.<sup>2</sup>

Next paragraph text would go here, without indentation (unless you are starting a new topic/paragraph).

## V. Headings

If you choose to use headings please format them as follows:

- A. Capitalize the first word and every important word in the heading title (headline style)
- B. Font: Times New Roman, 12-point, bold type
- C. Alignment: center
- D. Spacing: double space before and after (one line of space before and after)

## VI. Footnotes (do not use endnotes)

- A. Again, do not use endnotes
- B. Font: Times New Roman, 10-point
- C. Spacing: single (one line of space between footnotes)
- D. Left justify margins
- E. Indent for first line: 0.5"
- F. Use a single space between the Footnote superscript number and the Footnote citation text. For example, see the space between the number "2" superscript and "Rex" at the bottom of this page.
- G. Reference # in text: 12-point superscript
- H. Reference # in footnote: 10-point superscript

Please note the following about footnotes (as opposed to bibliographic entries):

- A. List author's name: First Name/Last Name
- B. Abbreviate editor and translator designations
- C. Place publishing information within parentheses
- D. Indent the first line of a footnote 0.5" (do not use a hanging indent)
- E. Do not separate footnotes with a double space.

- A. When quoting Scripture use the following in-text notation and punctuation:
  - "I am the way the truth and the life" (Jn. 14:6).
  - "Lord, are you going to wash my feet?" (Jn. 13:6).
- B. When quoting Scripture over three lines, format as per block quote above. Do not put a period after the Scripture reference in a block quote. Do not use quotation marks in a block quote unless material is quoted within the quote.
- C. The abbreviations that should be used to refer to the various biblical books in parentheses and footnotes are the following (some short names are not abbreviated):

Examples of footnote citations appear at the bottom of the page as footnotes. The bibliographic information is presented in the format a bibliography should take. Note: last name first when citing the author in your bibliography, first name first in footnotes. Make sure to create your bibliography in alphabetical order with each entry using hanging indents. (See the sample bibliography in Turabian, *A Manual for Writers*, 9<sup>th</sup> ed.)

## **XVIII. Previously Cited References**

When first citing a book include the full information in the footnote. For example: "The problem is that with enough imagination, and enough cynicism, we can find a reason to impugn *anyone's* objectivity."<sup>25</sup>

If the citation is to the same book and page as the immediately preceding footnote, use *ibid*.: "If we go to that extreme, however, then we lose all the advantages of having specialists in different fields "26"

If the citation is to the same book, but a different page, use *ibid* and the new page number: "The *post hoc* fallacy is probably the source of many superstitions."<sup>27</sup>

In all other cases, refer to a previously cited work by giving the author's last name, a short title for the book, and the page number. The example that we use here is found under the heading "Book/Monograph (Single Author)." "One chief consequence of the filling of the Spirit, as recorded in Acts, was the presence of power and authority in speech." 28

Do not use loc. cit. or op. cit.

For successive bibliographic entries by the same author, editor, or translator, a 3-em dash followed by a comma should be used to replace the name after the first appearance.
